Initial Fee

The Initial Fee is \$1,000, payable as follows:

DOWN PAYMENT. Applicant shall deposit \$1,000 with Twin Oaks Country Club (“TOCC”) simultaneously with this application. If this application is accepted, said sum shall become the property of TOCC.

If this application is rejected, TOCC shall return said sum to Applicant.

If Applicant remains a Junior member until Applicant becomes eligible for Regular membership, and if Applicant applies for Regular membership within 30 days after becoming eligible a deposit must be made with the Treasurer the lesser of either (1) the Regular membership Initial Fee which was in effect when the Junior member joined, or (2) the Regular membership Initial Fee in effect when the Junior Member becomes eligible for Regular Membership, including dues and taxes.

The amount due by Applicant on the down-payment for Regular membership shall be calculated in accordance with Article II, Section 4, of the bylaws which provides, in pertinent part:

“(A) . . . Any portion of the annual dues of a Junior member which exceeds one-half of the annual dues of a Regular member shall be classified as Junior Credits and apply to the Initial Fee of Regular membership, pursuant to clause (A, 1) . . .

(A, 1) . . . The Initial Fee for Junior membership previously paid and all Junior Credits shall be applied to the Initial Fee for the Regular membership. In addition, after attaining the age of 30, each Junior membership shall be charged a fee equal to 5% of the existing Regular Initial Fee, which shall be considered as Junior Credits to be used toward the Regular Initial Fee at the time of conversion from Junior. This Special fee may be paid in an annual payment or over 12 months (with a 5% bookkeeping fee).”

Dues

Dues for Junior members on the date of this application are \$213 per month or \$2,454 annually. Applicant shall pay dues (monthly) (annually).

Food Minimum

All categories of membership have a \$45 per month Food Minimum. Members with surnames beginning with letters A through K are on a billing cycle of the first day of the month through the end of the month. Members with surnames beginning with letters L through Z are on a billing cycle of the sixteenth day of the month through the fifteenth day of the following month.

Conditions

Applicant understands this application is subject to approval by the Board of Directors of TOCC. If accepted, this application becomes a contract between Applicant and TOCC. Applicant agrees that all persons using TOCC under Applicant's membership, including Applicant, are bound by and must comply with all by-laws, rules and regulations of TOCC as they now exist or may hereafter be amended. Applicant shall timely pay all charges and fees incurred by (a) Applicant and members of Applicant's family as defined in Article II, Section 12, of the by-laws, and (b) any Significant Other designated by Applicant pursuant to Article II, Section 12.
